- Launch of Jordan's first Master's program in Financial Technology and Accounting Analytics, where I developed the curriculum and handled local accreditation requirements as the head of the department in 2022.
- For more than six years, I have been utilizing innovative tools like Kahoot for interactive learning and advanced platforms like McGraw-Hill Connect for flexible, diverse quizzes in courses such as Cost Accounting, Accounting Theory, Managerial Accounting, and Principles of Accounting, exposing students to digital accounting concepts.
- In the cost accounting course, I have been using case studies in quizzes and exams since 2024.
- Curriculum mapping and program/courses development: I have significantly contributed to the development and international recognition of the accounting bachelor's program in PSUT by leading the efforts to secure two major global accreditations. In 2023, I led the process for PSUT to obtain the IMA Endorsement for the Bachelor of Accounting program, aligning our courses with CMA competencies and improving students' professional readiness. In the same year, I also led the ACCA accreditation process, making PSUT the first university in Jordan to receive this recognition. While these were team achievements, I handled and coordinated the key work required, including curriculum mapping, course development, documentation, and communication with the accreditation bodies.
